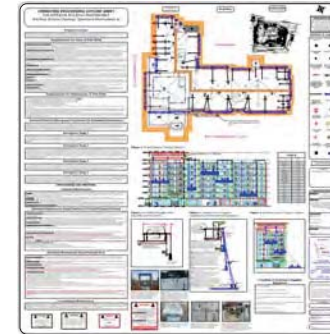
# ANNUAL INSPECTION
